Other matters not affecting our opinion which we draw to the attention of the smaller authority:

- We note that the Council did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2016/17 for the exercise of public rights, since the approval date was on the start of the period for the exercise of public rights. As a result, the Council must answer 'No' to Assertion 4 of the Annual Governance Statement for 2016/17 and ensure that it makes proper provision for the exercise of public rights during 2017/18.
- Box 11 on page 3 was not completed when the return was submitted. The answer should be "No" if the Council does not act as sole trustee.
