10. Planning

Cllr Regan reported on the following:

142905: San Remo, East Lane. New detached dwelling on land adjacent to existing dwelling.

Dedham Parish Council considers that because the location is outside the village envelopes a new development with no existing building footprint would create a precedent against the policies of the Village Design Statement. Recommendation: Refusal.

143732: 12, Kiln Cottages, Crown Street. Two storey extension to side and ground floor extension to rear The overall increase in the size of the property is disproportionate and too large for the plot to the detriment of the surroundings and street scene.

There is strong opposition from neighbors an all sides which the Parish Council notes and believes it responsible to support.

Recommendation: Refusal

144617: 3, Brook Cottages, Brook Street. Reduce height of yew and general tree maintenance

Recommendation: No objection

144603: Lavender Cottage, Coles Oak Lane. Single storey rear extension

Recommendation: No objection

144581: Pentire, Long Road West. Prior notification of proposed rear extension under 6metres in depth No comment required

144639: Stour Lodge, Long Road East. Two storey rear extension

Recommendation: No objection

DPC unanimously agreed the recommendations.

16. Donation towards new bench on playing field.

Cllr Regan proposed £100 is contributed to the removal of an old park bench, for the installation of a new one, in memory of Les and Peggy Brooks. Seconded by Cllr follows, 5 councillors in favour, 2 abstained. Carried.

IT WAS RESOLVED THAT DPC contributes £100 towards the replacement bench.

17. Correspondence

DPC received a request for a water table at the bottom on Gun Hill during a trail marathon. Agreed in principle, provided they contact the appropriate land owners/authorities
